Under Economic Substance, if an Isle of Man company's sole function is to acquire and hold controlling equity positions in other companies i.e. more than 50% of the company's share capital, then the company is considered a Pure Equity Holding Company. A Pure Equity Holding Company must demonstrate that its Core Income Generating Activities ...

File an annual return. The annual return is a snapshot of the company on the anniversary of incorporation. Due for filing within 1 month of its made up date, the annual return is the one document which every company must file on a yearly basis regardless of whether a company is trading or not. Failure to file an annual return may result in the officers of the company being ...
