

What is Gie AGSI & TP?

The Agency for the Cooperation of Energy Regulators (ACER) published an in-depth report on the Gas Storage Regulation, and GIE AGSI +TP was one of their main sources of information for providing key storage indicators per country.

What does AGSI do?

AGSI delivers online daily data representing approximately 76 BCM, i.e. 85 % of EU technical storage capacity. It publishes for 31 storage operators in 15 member states, volume in stock as well as the daily injection and withdrawal.

What is Gie AGSI & Alsi transparency platform?

GIE's AGSI and ALSI Transparency Platforms provide inventory reporting in daily resolution for underground gas storages and large-scale LNG terminals.

What is AGSI & Alsi?

As a voluntary initiative by storage and LNG operators, it can be considered as a benchmark to monitor pan-European filling levels for storage and send-out by LNG terminals. 100% of the market of underground gas storage in the EU27 is covered on AGSI and 100% of EU27 large-scale LNG terminals are listed on ALSI.
