MEWR ( Ministry of Energy and Water Resources) is responsible for energy generation in Barbados. The Ministry of Environment and National Beautification oversees environmental protection through permitting. The Project Monitoring & Coordination Team ensures energy projects align with the BNEP 2019-2030.
