Will Guernsey gas prices rise 10% from 1 January?

Guernsey Energy says the price of wholesale gas has been hit by world events. Island gas prices will rise by 10% from 1 January, Guernsey Energy has announced. The island's sole gas supplier said that for an average household, it would mean an increase of approximately €9.37 per month.

Who is Islands Energy Group?

Islands Energy Group is made up of three businesses based in Guernsey, Jersey and the Isle of Man - Guernsey Energy, Island Energy and Isle of Man Energy. It is the only gas supplier for domestic, commercial and industrial customers in the islands. It also sells domestic appliances including cookers and washing machines.
