How much power does statera have?

Set up in 2015, Statera has 1 GW of flexible generation in operation and under construction, a capacity enough to power around 750,000 homes. Is statera a bankable asset class?

Five years ago Statera secured a refinancing for a 50MW BESS in the UK which participating bank Natwest called a "milestone transaction" and CEO Tom Vernon said demonstrated the bankability of the asset class. Will statera's Bess project go online?

Statera has not revealed when it expects any phase of the project to go online but implied the BESS will be the first to start construction. Lloyds Bank was the sole structuring bank for the debt facilities with participation from NatWest, Santander, and Siemens Financial Services through Siemens Bank.

Statera Energy has unveiled plans to construct the UK's first utility-scale green hydrogen facility in Aberdeenshire--Kintore Hydrogen. This landmark project aims to bolster the UK's energy security by leveraging surplus renewable energy to produce green hydrogen, with a capacity to save up to 1.4 million tonnes of CO2 annually when fully operational at 3 GW.

The firm agreed a deal with InfraRed Capital Partners to acquire Statera Energy earlier this month (6 November).
