Will Hohm be profitable by 2024?

Ohlsen told TechCabal in February the company was on track to be profitable by the end of 2024. Hohm rapidly increased its headcount in anticipation of growing demand for solar, said Bas Hochstenbach, managing partner of E4E Africa, one of Hohm's investors.

Is Hohm still trading?

"We are working with legal counsel to get a better understanding of a way forward, but Hohm is currently not trading," Franc Gray, CEO of Hohm's parent company, Spark Energy, told TechCabal. CEO Tim Ohlsen left the company last week, people familiar with the matter said.
