The code, an initiative supported and sponsored by the SFC, was led by the Hong Kong ESG Ratings and Data Providers VCoC Working Group (VCWG) (Note 1). The International Capital Market Association (ICMA),

which has acted as the Secretariat of the VCWG in the formulation of the VCoC, will host and maintain the code (Note 2).
