

Does Ireland have a diplomatic presence in Africa?

Building on Ireland's longstanding engagement with Africa, and as part of the Government's Global Ireland initiative, this Strategy frames an expansion of Ireland's diplomatic presence on the continent. Three new Irish Embassies will be opened in North and West Africa.

How many embassies does Ireland have in Africa?

Following the opening of new Embassies in Morocco (2021) and Senegal (2023), Ireland's diplomatic presence on the continent of Africa has now grown to 14 Embassies from Cairo to Pretoria. This deepening of ties with Africa was envisaged under 'Global Ireland: Ireland's Strategy for Africa to 2025', launched in November 2019.
