Who is Wartsila Oyj Abp?

Wartsila Oyj Abp provides technologies and lifecycle solutions for the marine and energy markets. The Company offers engines, propulsion systems, hybrid solutions, data and digital tools, liquid and gas handling on vessels, and integrated powertrain systems, as well as services to manage and optimize complex energy systems.

What happened to Wartsila?

Wartsila acquired John Crane-Lips, which operates within Wartsila; under the name Wartsila; Propulsion 2001: Wartsila; sells its holding in Sanitec and takes ownership of service companies Ciserv AB and Sermet Oy 2000: Wartsila; NSD and John Crane-Lips sign an alliance; Metra group is renamed Wartsila; Corporation

Who owns Wartsila; Marine Turku?

The former Wartsila; Marine Turku Shipyard is now owned by Meyer Werft under its Meyer Turku subsidiary and the Helsinki shipyard is operated by a company of the same name owned by the Canadian Davie Shipbuilding. Wartsila; is a provider of power plants in distributed and flexible power generation.

Where is Wartsila headquartered?
