The Solar Investment Tax Credit is a federal tax credit that can reduce the costs of a residential solar system by up to 30% for homeowners who buy a the system outright. New Jersey has two solar incentives in the form of tax exemptions. First, there is a sales tax exemption for the 6.625% state sales tax rate. That amounts to \$1,656.25 in avoided sales tax on a \$25,000 solar system. New Jersey also has a property tax exemption that applies to 100% of the value added to your home by an active solar system.

There are several alternative models of solar energy system ownership in New Jersey's solar market. Ownership of SRECs often remains the same as ownership of the solar energy system. Frequently, the ownership of SRECs is transferred by the owner of the solar energy system to a third party in exchange for a reduction in installed costs.

As of Nov 2024, the average cost of solar panels in Hillside is \$2.74 per watt making a typical 6000 watt (6 kW) solar system \$16,463 before the federal solar credit and \$11,524 after claiming the federal solar tax credit.

How Much Do Solar Panels Cost in New Jersey? The average homeowner in New Jersey will pay around \$16,513 for a solar panel system after the federal solar investment tax credit (ITC) is considered. Before the credit, you're looking at an average total of \$23,590.
