The Department does not require a power of attorney to be completed to receive such information. Withdrawal of Liens - If the taxpayer believes that a lien was filed in error, the taxpayer may request a withdrawal of the tax lien. If the Department determines that the lien was filed in error, the lien will be withdrawn.
