

# Methanol storage Timor-Leste

Who approves storage facilities for fuels in Timor-Leste?

Under Decree-Law No. 1/2012, of 1 February, the Autoridade Nacional do Petr&#243;leo (ANP) has generic powers to approve the technical requirements, principles and conditions to be met in the installation and operation of Storage Facilities for Fuels in Timor-Leste.

How to dispose of oil contaminated water in Timor-Leste?

Storage Facilities must be equipped with a system for treating wastewater contaminated with hydrocarbons. Water is deemed suitable for disposal/discharge if the oil in water content is less than 10 mg/l or in accordance with the applicable law in Timor-Leste.

Why is IFC partnering with Timor-Leste's ANPM?

According to Florentino Soares Ferreira, President of Timor-Leste's National Authority of Petroleum and Minerals (ANPM), "this agreement with IFC will help to ensure that best practice is applied to this project and that the interest of Timor-Leste and its people are put first.

When is water deemed suitable for disposal/discharge in Timor-Leste?

Water is deemed suitable for disposal/discharge if the oil in water content is less than 10 mg/l or in accordance with the applicable law in Timor-Leste. The oil separators must be installed in locations easily accessible for inspection and cleaning.
