

What is happening in Namibia's energy sector?

Namibia's energy sector has seen rapid development in a short period of time owing to five recent major oil and gas discoveries, which include the Venus-1X, Graff-1X, Jonker-1X, La Rona-1X, and Lesedi-1X exploration projects.

How is energy used in Namibia?

Total energy supply (TES) includes all the energy produced in or imported to a country, minus that which is exported or stored. It represents all the energy required to supply end users in the country.

Can bioenergy be used in Namibia?

Bioenergy from specially cultivated energy crops is out of the question in Namibia due to land competition with food production and water scarcity. The natural potential for hydropower is estimated at 2,250 MW. Of these, 347 MW are already being used from Ruacana hydro-electric power station.

What are the different types of energy transformation in Namibia?

One of the most important types of transformation for the energy system is the refining of crude oil into oil products, such as the fuels that power automobiles, ships and planes. No data for Namibia for 2022. Another important form of transformation is the generation of electricity.

Does Namibia need electricity?

Namibia is heavily dependent on imports for its energy supply. All fossil fuels (coal, fuels) must be imported. Despite the small population and the low electrification rate of 56%, only about 40% of the country's electricity needs can be met from its own generation capacities.
