What happened to NextEra Energy & Energy Future Holdings?

NextEra Energy and Energy Future Holdings, parent company of Texas -based utility Oncor Electric Delivery, reached a \$18.7 billion merger agreement on July 29, 2016, but the agreement was terminated in July 2017 after the Texas Public Utility Commission rejected the offer over disagreement on the control of Oncor's board of directors.

How much is NextEra Energy worth in 2023?

In 2023, NextEra Energy's market value stood at over 150 billion U.S. dollars. The United States-based company is also one of the leading green electric utilities in the world, as its renewable energy capacity increased six-fold between 2005 and 2022.

Will NextEra buy Gulf Power Company?

In May 2018, NextEra Energy announced that it planned to buy Gulf Power Company, the largest electricity producer in Northwest Florida, from Southern Company in a \$6.4 billion deal, pending approval from regulators.

NextEra Energy Resources and Sonoma Clean Power launched the Golden Hills North Wind Energy Center in California, a repowering project that replaced 283 30-year old wind turbines with just 20 new 2.3-MW GE turbines capable of generating even more power with twice the efficiency.

The acquisition was closed for a consideration of almost \$660m, including the assumption of debt. A subsidiary of NextEra Energy, NextEra Energy Transmission operates in California, New Hampshire and Texas. It currently has several projects under development across the US and Canada.
