In brief. Certain tax credits enacted or amended by the Inflation Reduction Act of 2022 provide for a base credit rate and a bonus credit. Taxpayers that meet certain requirements to pay prevailing wages to workers employed in constructing, repairing, or altering facilities and to hire workers from apprenticeship programs may be able to claim a bonus credit five times the base rate.
