Cleco Corporate Holdings purchased NRG's South Central businessfor \$1 billion in price and cash proceeds. The South Central business had 3,500 MW generation capacity,including the natural gas facilities Bayou Cove plant (225 MW),Sterlington plant (176 MW),and the Cottonwood plant (1,263,000 MW).
