St. Kitts and Nevis will add a utility-scale solar and storage plant to meet one quarter of its electricity needs. The 35.6MW solar park and 44.2MWh battery storage facility will be built and operated by Leclanché, a Swiss firm acting as EPC contractor. ... Construction has begun on a solar-plus-storage project on the Caribbean island of St. Kitts & Nevis, backed by Leclanché, Solrid and MPC Energy Solutions.
