

1 ?· The Abydos Solar PV Plant was financed by the International Finance Corporation (IFC), the Dutch Entrepreneurial Development Bank (FMO), and the Japan International Cooperation Agency (JICA). In September 2024, EliTe Solar announced investment plans to build an 8 GW solar manufacturing hub in Egypt's Suez Special Economic Zone.

The Dutch government has officially announced the termination of its residential solar net metering program by 2027. The Dutch Solar Energy Association welcomed this decision, acknowledging that the current program is no longer sustainable.
