Hence, the ratio of total energy remunerated over energy discharged from storage, 3.9, needs to be multiplied with the storage adder to calculate the actual remuneration for energy discharged from the storage system. That results in an "adjusted adder" per energy from the energy storage system of $US\$20 \text{ USD/MWh} * 3.9 = US\$78 /\text{MWh}$.

Energy-Storage.news has reported on similar deals during 2021 for CCAs like Desert Community Energy, which signed a 20-year PPA with developer Vesper Energy for the output of a 50MW PV plant with 200MWh of battery storage, announced in May; San Diego Community Power's PPA with developer Baywa r.e. for a 70MW PV plant with 280MWh of DC ...

APS has just signed another 20-year storage PPA, with Canadian Solar's developer subsidiary Recurrent Energy for the 600MWh Desert Bloom Storage BESS project alongside a solar deal and building on a 1.2GWh storage agreement between the pair signed last year, projects which like EDF's Beehive BESS are also in Maricopa County.

Investor DIF and renewable energy optimiser Pexapark have announced what they claim is the UK's "first bankable and unsubsidised co-located PPA", for a solar and storage project. The hybrid power purchase agreement (PPA) supported by Pexapark covers a 55MW solar farm with 40MW/80MWh of battery energy storage capacity co-located.
