Aggreko was founded in The Netherlands by Luc Koopmans in 1962. It moved to Scotland in 1973. In 1984, it was acquired by Christian Salvesen plc in 1984, a Scottish transport and logistics company. In 1997, the business demerged from Christian Salvesen and then listed on the London Stock Exchange.

What is Aggreko Power?

Aggreko is the world's largest temporary power company. It has more than 10 gigawatts of power across its fleet globally. The company employs over 6,000 people and operates across the world in more than 200 locations in 80 countries and has offices in every continent.

Who is Aggreko North America?

From about 50 locations, Aggreko North America provides cooling, heating, and electrification services at natural disaster sites, as well as for more controlled events, such as the Super Bowl, the Olympic Games, and movie sets.

Who is the CEO of Aggreko energy?
