What is the largest power station in Zimbabwe?

Situated in the North Western part of Zimbabwe, Hwange Power Station is the largest coal-fired power station with 920MW installed capacity which comprises of 4x120MW and 2x220 MW units. ... In 1955, it was decided to dam the Zambezi River at the Kariba Gorge to supply power to Zimbabwe and Zambia.

Who is Zimbabwe Power Company (ZPC)?

Zimbabwe Power Company (ZPC) was incorporated in 1996 as an investment vehicle in the generation of electricity and became operational in 1999. The organisation has been authorised to construct, own, operate and maintain power generation stations for the supply of electricity.

Where is the largest coal-fired power station in Zimbabwe?

Hwange Power Station, located in the North Western part of Zimbabwe, is the largest coal-fired power station in the country. In 1955, it was decided to dam the Zambezi River at the Kariba Gorge to build this Power station. It is located in the Workington area of the capital city along Coventry Road.

Why did Mnangagwa build a new power station in Zimbabwe?

The new power station also allowed Mnangagwa to show he still has good friends in the international arena, where Zimbabwe is largely isolated. The plant, the expansion a pre-existing station, is one of four energy projects undertaken with a \$1.2 billion loan from China, with which Harare has ties dating back to fight for independence from Britain.

Zimbabwe's President Emmerson Mnangagwa on Thursday inaugurated a Chinese-funded power station that he said would go a long way in easing power shortages ahead of national elections.

Will ZPC expand Hwange power station?

In August 2018, ZPC officially commenced expansion works at Hwange Power Station which will result in a third stage being added to the station with 2 x 300MW units being constructed. The expansion project will increase Hwange's generation capacity from the current 920MW to 1520MW.
